





Such of the proposals which have fulfilled the norms, have been recommended by the Expert Committee for sanction of research grants.

The Syndicate in its meeting held on 20-10-2022 has approved to sanction the grant-in-aid as per the recommendations of Expert Committee for 355 selected proposals in Medical, Dental, Pharmacy, AYUSH, Nursing, Physiotherapy, Homoeopathy and Allied Health Sciences for UG students for the year 2022-23.






